I again want to say a special thanks to all those who have been so instrumental in all of our activities to date and those who will help in many ways the remainder of the year.



Code Updates on the Horizon

TABA President Mike Pilkington and I recently met with Temple Construction Safety Director Richard Therriault about coming changes to mechanical, plumbing, and electrical codes. Mr. Therriault noted that the City would like to go ahead and update all of their codes to the level of the 2006 International Residential Code where it makes sense for our area. It is his belief that the new "minimum codes" are already being followed by most builders and subcontractors in our area—in some instances without them even realizing it.

He further stated that upon attending a considerable amount of training on the new codes he is of the belief that the codes are actually less restrictive in many areas where common sense has come into play. For instance he provided an example of a reduction in the necessary hour ratings for fire walls that are used in non-restaurant commercial applications. Apparently 2 hour rated walls have been required in numerous instances where one hour walls would have been more than adequate.

Most notable among Mr. Therriault's comments on the matter was that he does not foresee any major changes in which updating the code will create significant cost increases for area builders and that a transitional period (official or unofficial) will be part of the process so that builders will have time to base their bids on whatever the new codes call for.

As is customary these days at the City of Temple, Mr. Therriault would like to include stakeholders in the process of updating the codes from the very early stages. Any interested builder, superintendent, or subcontractor is asked to contact the <u>Construction Safety Department</u> at the city offices at 254-298-5641 to make them aware of your interest to serve on the code committee.

It is likely that the process will get underway on Friday, June 8th. Feel free to contact me at 254-773-0445, if you would like me to contact the City for you.

Comprehensive Plan Work Continues

Several meetings related to the Comprehensive Plan were held during the past month. Perhaps the most

significant to our industry was the "Community Design Workshop." The meeting was very well attended by the development community. During the meeting attendees broke out into groups to review areas of focus for the City (corridors, gateways, landmarks, etc). When the group came back together we had some good discussion on industry issues that come up when the City starts talking about items relating to urban design (tree preservation, water features, open space, sidewalks, etc).

Points of concern that were raised can best be summed up in one word—COST. We believe that item has to be foremost on the City's mind when they consider the amenities that are being discussed at these meetings.

This not to say that we aren't supportive of making our city(s) more attractive. We fully realize that the more attractive our city is, the more enjoyable it is. In turn, more people will want to live here, and our members will be able to continue building homes.

The bottom line though is that TABA will continue to advocate for the high level of affordability of housing in our area which hasn't come about by chance. Our industry leaders work hard to make sure that homebuyers can afford the products that our members put on the market.

The City needs to assure that as they plug 'urban paradise' to the constituency that they also make sure our citizens realize that none of the items that they are talking about are free and in the end, it is the homeowner and taxpayer that pays for all of the conveniences that the City considers.

It is TABA's philosophy that the market should dictate the need for neighborhoods with amenities like larger lot size and common areas such as sidewalks, swimming pools, and public open space. There is no doubt that there are people that put a great deal of value into those amenities. On the other hand, there are also a lot of folks who are simply looking for a quality place to call home and provide shelter to their family.

TABA will continue to work with our municipalities to make sure that both ends of the spectrum can be served in the Temple marketplace.

So far Home-PAC is two of three as far as the May 2007 elections go. The good news is that the \$19.9 million TISD school bond passed with about 62 percent of the approval of almost 2,600 voters.

The not-so-good news is that the TISD candidate election did not go as smoothly as most would hope. A controversial run-off election will be required. It is controversial because the candidates were told at an orientation that the election would be decided by plurality instead of by majority. In the end, it was determined that the race was legally required to be decided by majority (which none of the candidates in contested races won), hence a run-off is required.

Dow Fogleman, whom Home-PAC supports, beat incumbent Virginia Suarez with 77 votes to 58. Garry Smith who also ran in the district got 23 votes. The run-off between Fogleman and Suarez gives both candidates time to go out and beat the bushes for more votes and with relatively few taking advantage of their right to vote in that district, it shouldn't take much to make this an even more interesting race.

In TISD District 7, Mary Klentzman beat her closest opponent A'Lisa Ozment 165 to 113, but the votes that went to opponents Elwyn Johnston (91) (Home-PAC supported) and Bill Gorden (33) could sway that outcome as well depending on which run-off candidate they go to.

Early voting began on May 29th and run-off election day is June 9th. If you live in either TISD District 1 or 7, please get out and exercise your right to vote.

TRCC Contracts Training...



It appears substantial revisions to the Texas Residential Construction Commission are being adopted by the 80th Texas Legislature through the passage of <u>House Bill 1038</u>. The bill was recently sent to Governor Perry for signature (with no foreseeable objections by the Governor).

In addressing these changes the Temple Area Builders Association is working with the attorneys who have worked with our association to create the TRCC contracts package that is available to all of our members. These attorneys will put on a seminar in Temple titled *TRCC Update: New Contractual Disclosures and Severe Penalties*. This will likely be the most important contracts seminar of the last few years due to the revisions.

The likely training date for the seminar is scheduled for **June 27th from 3 to 5 pm**. Be on the lookout for further information next month.

Please also mark **Thursday**, **September 6th** on your calendars for some very important training on storm water issues.

Storm Water Training...



Over the past few years the Texas Association of Builders has developed a good working relationship with the EPA and the TCEQ and together they've worked to ensure that the fines for storm water non-compliance are not so often for paperwork violations, but for actual environmental damages.

Most of <u>our readers also know</u> that the TCEQ is in the process of approving the permit for cities that have

populations of less than 200,000, or the "MS4" or "Phase II" cities. (The first cities "Phase I" that have been under EPA and TCEQ storm water regulation for several years are those with populations of over 200,000.)

With the new permit due this summer and the changes that we are seeing with the EPA, it's time to bring everyone – builders, inspectors, local building officials, EPA, TCEQ – together so that everyone will be on the same page. Therefore, the Texas Association of Builders is developing this new training seminar.

There is a great deal of information available on storm water compliance, but the most easy to read guide is on the <u>EPA website</u>. TAB will be using this document in the trainings which will be conducted by Paradigm Engineering.

Be on the lookout for additional information as the training date approaches.
